Director of Live Events – To ensure effective health and safety at events.

Team Leaders and Managers – To ensure effective safe systems of work are in place to protect their Team Members. To ensure their team members are competent regarding health and safety. To provide their team members with required resources to support effective health and safety.

People Team – To arrange H&S training and to maintain records.

Our Team Members – To co-operate with managers and leaders on all health and safety matters, to take reasonable care of their own health and safety and report all health and safety concerns.
